## 2009 Young Artists Concerto Competition Application Saturday, February 28, 2009

### RULES AND REGULATIONS

1. Contestants must play one movement of a selection for solo and orchestra.
2. Competition is open to all instruments, including percussion.
3. Contestant must be a resident of New Jersey or studying in a school in New Jersey.
4. Orchestral parts and score must be available.
5. Piece must be performed from memory.
6. Contestants must perform with an accompanist. If needed, the organizer has names of staff pianists who can accompany contestants. The fees shall be arranged between the contestant and the accompanist directly.
7. Applications must be postmarked by February 1, 2009, with a registration fee of \$50. The fee is non-refundable. Checks payable to **Bravura Philharmonic Orchestra**.
8. Contestants must be born after February 1, 1990 (not exceeding 18 years old.) There is no minimum age requirement.
